Payment at Maturity:

Payment at maturity will be based on the price performance (or "Percentage Change") of the Index measured from the Initial Index Level to the Final Index Level. The amount payable (the "Redemption Amount") on each US\$100 Principal Amount per Security at maturity will be determined as follows:

If the Percentage Change in the Index is **greater than or equal to 52.00**%, then the Redemption Amount will be:

US\$100 + (US\$100 × Percentage Change)

If the Percentage Change in the Index is **zero or positive and less than 52.00%**, then the Redemption Amount will be:

• US\$100 + (US\$100 × Booster Amount)

If the Percentage Change in the Index is **negative**, **declining by 20.00% or less** (i.e., less than or equal to the Buffer of 20.00%), then the Redemption Amount will be:

• US\$100 + (US\$100 × the absolute value of the Percentage Change)

If the Percentage Change in the Index is **negative**, **declining by more than 20.00%** (i.e., beyond the Buffer of 20.00%), then the Redemption Amount will be reduced by the amount of any decline beyond the Buffer, and the Redemption Amount will be:

• US\$100 + [US\$100 × (Percentage Change + 20.00%)]

All dollar amounts will be rounded to the nearest whole cent.

Percentage Change:

The "Percentage Change" is the amount, expressed as a percentage rounded to three decimal places, equal to:

(Final Index Level – Initial Index Level)

Initial Index Level

Booster Amount:

52.00%, applied only if the Percentage Change is greater than or equal to 0.00% and less than 52.00%.

Buffer:

20.00%. The principal of the Securities will be protected against a decline of up to 20.00% in the price performance of the Index.

Initial Estimated Value:

The initial estimated value of the Securities as of July 4, 2017 was US\$93.64 per Security, which is less than the price to the public and is not an indication of the actual profit to the Bank or its affiliates. The actual value of the Securities at any time will reflect many factors, cannot be predicted with accuracy, and may be less than this amount. The initial estimated value of the Securities is an estimate only and is based on the value of the Bank's obligation to make the payments on the Securities. Sample Calculations of the Redemption Amount

the Redemption Amount: Sample Calculations of Redemption Amount

The examples set out below are included for illustration purposes only. The levels of the Index used to illustrate the calculation of the Redemption Amount are not estimates or forecasts of the Initial Index Level and Final Index Level on which the calculation of the Percentage Change, and in turn the Redemption Amount, will depend. All examples assume that a holder of the Securities has purchased Securities with an aggregate Principal Amount of US\$100 and that no Extraordinary Event has occurred. All dollar amounts are rounded to the nearest whole cent.

Example #1 — Calculation of the Redemption Amount where the Percentage Change is negative and beyond the Buffer (i.e., the price performance of the Index has declined by more than 20.00%)

Assuming that the Initial Index Level is 3,479.47 and the Final Index Level is 1,496.17, the Redemption Amount would be calculated as follows:

Initial Index Level = 3,479.47 Final Index Level = 1,496.17

Percentage Change =
$$(\frac{1,496.17 - 3,479.47}{3,479.47})$$
 = -0.5700 or -57.00%

Since the Percentage Change is negative and beyond the Buffer, the Redemption Amount is calculated as follows:

Redemption Amount = US100 + [US$100 \times (-57.00\% + 20.00\%)] = US63.00

In this example, the Redemption Amount results in a loss on the Principal Amount equivalent to an annually compounded loss rate of 7.41%.

Example #2 — Calculation of the Redemption Amount where the Percentage Change is negative and less than or equal to the Buffer (i.e., the price performance of the Index has declined by 20.00% or less)

Assuming that the Initial Index Level is 3,479.47 and the Final Index Level is 3,305.50, the Redemption Amount would be calculated as follows:

Initial Index Level = 3,479.47 Final Index Level = 3,305.50

Percentage Change =
$$(3,305.50 - 3,479.47)$$
 = -0.0500 or -5.00%

Since the Percentage Change is negative and less than or equal to the Buffer, the Redemption Amount is calculated as follows:

Redemption Amount = US\$100 + (US\$100 x 5.00%) = US\$105.00

In this example, the Redemption Amount provides a return on the Principal Amount equivalent to an annually compounded rate of return of 0.82%.

Example #3 — Calculation of the Redemption Amount where the Percentage Change is zero or positive and less than 52.00%

Assuming that the Initial Index Level is 3,479.47 and the Final Index Level is 3,653.44, the Redemption Amount would be calculated as follows:

Initial Index Level = 3,479.47 Final Index Level = 3,653.44

Percentage Change =
$$(3,653.44 - 3,479.47)$$
 = 0.0500 or 5.00%

Since the Percentage Change is zero or positive and less than 52.00%, the Redemption Amount is calculated as follows:

Redemption Amount = US\$100 + (US\$100 × 52.00%) = US\$152.00

In this example, the Redemption Amount provides a return on the Principal Amount equivalent to an annually compounded rate of return of 7.23%.

Example #4 — Calculation of the Redemption Amount where the Percentage Change is greater than or equal to 52.00%

Assuming that the Initial Index Level is 3,479.47 and the Final Index Level is 5,462.77, the Redemption Amount would be calculated as follows:

Initial Index Level = 3,479.47

Final Index Level = 5,462.77

Percentage Change =
$$(5,462.77 - 3,479.47)$$

 $3,479.47$ = 0.5700 or 57.00%


Since the Percentage Change is greater than or equal to 52.00%, the Redemption Amount is calculated as follows:

Redemption Amount = US\$100 + (US\$100 × 57.00%) = US\$157.00

In this example, the Redemption Amount provides a return on the Principal Amount equivalent to an annually compounded rate of return of 7.81%.

GRAPHICAL DESCRIPTION OF THE PAYMENT AT MATURITY

The graph set out below is included for illustration purposes only. The Index levels used to illustrate the calculation of the payment at maturity are not estimates or forecasts of the Initial Index Level and Final Index Level on which the calculation of the Percentage Change, and in turn the Redemption Amount, will depend. This graph shows a limited range of hypothetical returns on the Index and is intended to be representative of that range only. Returns on the Index not shown on the graph are still possible to achieve and the corresponding returns on the Securities should be calculated using the formulas set out in the Pricing Supplement. This graph demonstrates what the return on the Securities will be for a specific return on the Index. There can be no assurance that any specific return will be achieved. All examples assume that a holder of the Securities has purchased Securities with an aggregate Principal Amount of US\$100 and that no Extraordinary Event has occurred. The minimum payment at maturity is US\$20.00.
