INVESTMENT HIGHLIGHTS

Issuer: Royal Bank of Canada

Currency: CAD

Term: Approximately 5 years

Underlying Index: The Variable Return will be determined by reference to the price performance of the S&P/TSX 60 Index. Notes do not represent an interest in the Index or in the securities of the companies that comprise the Index. Holders have no right or entitlement to the dividends or other distributions paid on these securities. The indicative dividend yield of the Index as of June 27, 2022 was 3.31%, representing an aggregate dividend yield of approximately 17.68% compounded annually over the 5 year term, on the assumption that the dividend yield remains constant.

Variable Return: The Variable Return, if any, on each Note upon maturity will be an amount equal to the Principal Amount multiplied by the Percentage Change multiplied by the Participation Rate. The Variable Return, if any, will not be less than zero.

Participation Rate: 119%

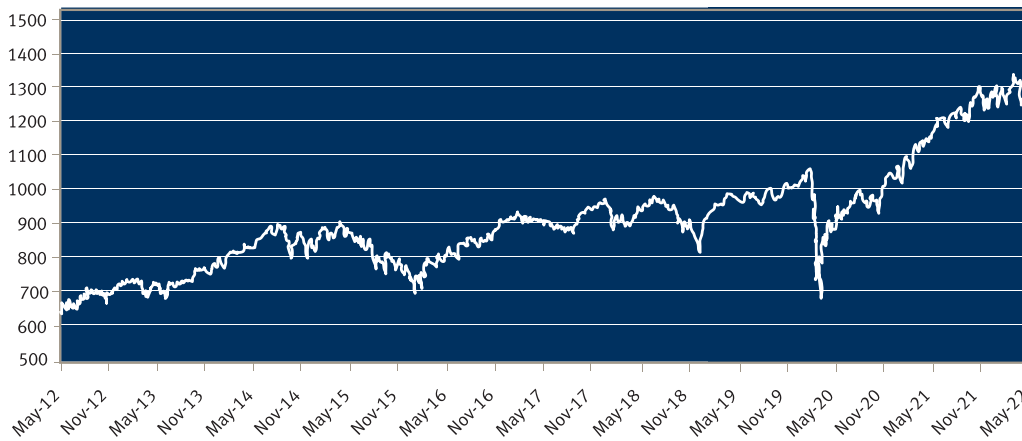
Credit Ratings: 100% principal protection guaranteed by RBC at maturity. RBC is rated Aa1 by Moody's, AA- by Standard and Poor's and AA by DBRS.

Secondary Market: The Notes are tradeable in a daily secondary market, subject to availability, which RBC Capital Markets will use reasonable efforts to provide as outlined in the Information Statement. An early trading charge may apply (initially 3.25%, reducing to 0% after 360 days). Proceeds on sale may be less than the \$100 Principal Amount.

Eligibility for Investment: RRSPs, RDSPs, RESPs, TFSAs, RRIIs and DPSPs.

S&P/TSX 60 HISTORICAL PRICE PERFORMANCE

SAMPLE CALCULATIONS OF THE PAYMENT AMOUNT

The examples set out below are included for illustration purposes only. The levels of the Index used to illustrate the calculation of Variable Return are not estimates or forecasts of the level of the Index on which the Base Level and Settlement Level or the calculation of the Percentage Change, and in turn Variable Return, will depend. All examples assume that a Noteholder has purchased Notes with an aggregate Principal Amount of \$10,000 and that no Extraordinary Event has occurred.

Example #1 — Hypothetical calculation of the Payment Amount where the Settlement Level of the Index is greater than the Base Level. It is assumed that the Base Level of the Index is 1,169.53 and the Settlement Level of the Index is 1,520.39 (hypothetical). The Payment Amount would be calculated as follows:

Base Level = 1,169.53

Settlement Level = 1,520.39

Percentage Change = $\frac{(1,520.39 - 1,169.53)}{1,169.53} = 0.30000$ or 30.000%

Variable Return = $\$10,000.00 \times 30.000\% \times 119.00\% = \$3,570.00$

Payment Amount = $\$10,000.00 + \$3,570.00 = \$13,570.00$

In this example, the Payment Amount provides a return equivalent to an annually compounded rate of return of 6.30%.

Example #2 — Hypothetical calculation of the Payment Amount where the Settlement Level of the Index is less than the Base Level. It is assumed that the Base Level of the Index is 1,169.53 and the Settlement Level of the Index is 818.67 (hypothetical). The Payment Amount would be calculated as follows:

Base Level = 1,169.53

Settlement Level = 818.67

Percentage Change = $\frac{(818.67 - 1,169.53)}{1,169.53} = -0.30000$ or -30.000%

Variable Return = $\$10,000.00 \times 0.000\% \times 119.00\% = \0.00

Payment Amount = $\$10,000.00 + \$0.00 = \$10,000.00$

In this example, the Payment Amount provides a return equivalent to an annually compounded rate of return of 0.00%.
