

#### **INVESTMENT HIGHLIGHTS**

Issuer:	Royal Bank of Canada
Currency:	USD
Term:	Approximately 5 years
Underlying Index:	The Variable Return will be determined by reference to the price performance of the S&P 500® Index. Notes do not represent an interest in the Index or in the securities of the companies that comprise the Index. Holders have no right or entitlement to the dividends or other distributions paid on these securities. The indicative dividend yield of the Index as of June 27, 2022 was 1.66%, representing an aggregate dividend yield of approximately 8.58% compounded annually over the 5 year term, on the assumption that the dividend yield remains constant.
Variable Return:	The Variable Return, if any, on each Note upon maturity will be an amount equal to the Principal Amount multiplied by the Percentage Change multiplied by the Participation Rate. The Variable Return, if any, will not be less than zero and will not exceed 45.00% of the Principal Amount. The maximum return will be earned if the Index rises by 45.00% or more from the Initial Valuation Date to the Final Valuation Date.
Participation Rate:	100%
Сар:	The Index is subject to a maximum appreciation of 45.00% (the "Cap"). As a result of the Cap, the maximum Percentage Change on each Note would be 45.00%, equivalent to an annually compounded rate of return of 7.71%.
Credit Ratings:	100% principal protection guaranteed by RBC at maturity. RBC is rated Aa1 by Moody's, AA- by Standard and Poors and AA by DBRS.

#### SAMPLE CALCULATIONS OF THE PAYMENT AMOUNT

The examples set out below are included for illustration purposes only. The levels of the Index used to illustrate the calculation of Variable Return are not estimates or forecasts of the level of the Index on which the Base Level and Settlement Level or the calculation of the Percentage Change, and in turn Variable Return, will depend. The Index is subject to a maximum appreciation of 45.00% (the "Cap"). All examples assume that a Noteholder has purchased Notes with an aggregate principal amount of US\$10,000 and that no Extraordinary Event has occurred.

Example #1 — Hypothetical calculation of the Payment Amount where the Percentage Change of the Index is positive and below the Cap. It is assumed that the Base Level of the Index is 3,900.11 and the Settlement Level of the Index is 5,070.14 (hypothetical). The Payment Amount would be calculated as follows:

Base Level = 3,900.11

Settlement Level = 5,070.14

Percentage Change = 
$$\frac{(5,070.14 - 3,900.11)}{3.900.11} = 0.30000 \text{ or } 30.000\%$$

Participation Rate = 100.00%

Variable Return = US\$10,000.00 × 30.000% × 100.00% = US\$3,000.00

Payment Amount = US\$10,000.00 + US\$3,000.00 = US\$13,000.00

In this example, the Payment Amount provides a return equivalent to an annually compounded rate of return of 5.39%.

Example #2 — Hypothetical calculation of the Payment Amount where the Percentage Change of the Index is positive by 45.00% or more and therefore capped at 45.00%. It is assumed that the Base Level of the Index is 3,900.11 and the Settlement Level of the Index is 6,279.18 (hypothetical). The Payment Amount would be calculated as follows:

Base Level = 3,900.11

Settlement Level = 6,279.18

Percentage Change = 
$$\frac{(6,279.18 - 3,900.11)}{3,900.11} = 0.61000 \text{ or } 61.000\%$$

Participation Rate = 100.00%

Variable Return = US\$10,000.00 × 45.000% × 100.00% = US\$4,500.00

Payment Amount = US\$10,000.00 + US\$4,500.00 = US\$14,500.00

In this example, the Payment Amount provides a return equivalent to an annually compounded rate of return of 7.71%.

### SAMPLE CALCULATIONS OF THE PAYMENT AMOUNT (CONT'D)

Example #3 — Hypothetical calculation of the Payment Amount where the Percentage Change of the Index is deemed to be zero. It is assumed that the Base Level of the Index is 3,900.11 and the Settlement Level of the Index is 2,730.08 (hypothetical). The Payment Amount would be calculated as follows:

Base Level = 3,900.11

Settlement Level = 2,730.08

Percentage Change = 
$$\frac{(2,730.08 - 3,900.11)}{3,900.11} = -0.30000 \text{ or } -30.000\%$$

Variable Return = US\$10,000.00 × 0.000% × 100.00% = US\$0.00

Payment Amount = US\$10,000.00 + US\$0.00 = US\$10,000.00

In this example, the Payment Amount provides a return equivalent to an annually compounded rate of return of 0.00%.
