

## Sample Calculations of Redemption Amount and Interest Payments

The examples set out below are included for illustration purposes only. The levels of the Underlying Index used to illustrate the calculation of the Redemption Amount are not estimates or forecasts of the Initial Index Level and Final Index Level, on which the calculation of the Redemption Amount will depend. All examples below assume that a holder of the Securities has purchased Securities with an aggregate principal amount of \$100.00, that no Extraordinary Event has occurred and a Protection Barrier Level of 75.00% of the Initial Index Level. For convenience, each vertical line in the charts below represents the Interest Payment Date falling on the next succeeding quarter. Certain dollar amounts are rounded to the nearest whole cent.

## Example #1 — Underlying Index Significantly Decreases With Payment on the Maturity Date Less Than the Principal Amount



In this scenario, on the Final Valuation Date, the Final Index Level is below the Protection Barrier Level. The Underlying Index has an Initial Index Level  $(X_i)$  of 767.57 and a Final Index Level  $(X_f)$  of 253.30. Therefore, the Redemption Amount would be calculated as follows:

Principal Amount of Securities  $\times$  (X<sub>f</sub> / X<sub>i</sub>)

$$100 \times (253.30 / 767.57) = 33.00$$

Since the monthly coupon of \$0.5925 per Security is not contingent on or related to the performance of the Underlying Index, the total Interest Payments during the term of the Securities are as follows:

Principal Amount of Securities × 0.5925% per Interest Period × 60 Interest Periods

$$100 \times 0.5925\% \times 60 = 35.55$$

Therefore, the total amounts payable to the holder of a Security during the 60-month period from the Issue Date to the Maturity Date are:


(a) Redemption Amount: \$33.00

(b) Total Interest Payments made: \$35.55

(c) Total amount paid over the term of the Securities: \$68.55

The equivalent annually compounded rate of return in this example is -7.27%.

Example #2 — Underlying Index Slightly Decreases With Payment on the Maturity Date Equal to the Principal Amount



In this scenario, on the Final Valuation Date, the Final Index Level is above the Protection Barrier Level. Therefore, the Redemption Amount would be equal to \$100.

Since the monthly coupon of \$0.5925 per Security is not contingent on or related to the performance of the Underlying Index, the total Interest Payments made during the term of the Securities are as follows:

Principal Amount of Securities × 0.5925% per Interest Period × 60 Interest Periods

$$100 \times 0.5925\% \times 60 = 35.55$$

Therefore, the total amounts payable to the holder of a Security during the 60-month period from the Issue Date to the Maturity Date are:


(a) Redemption Amount: \$100.00

(b) Total Interest Payments made on Interest Payment Dates: \$35.55

(c) Total amount paid over the term of the Securities: \$135.55

The equivalent annually compounded rate of return in this example is 6.27%.

Example #3 — Underlying Index Increases With Payment on the Maturity Date Equal to the Principal Amount



In this scenario, on the Final Valuation Date, the Final Index Level is above the Protection Barrier Level. Therefore, the Redemption Amount would be equal to \$100.

Since the monthly coupon of \$0.5925 per Security is not contingent on or related to the performance of the Underlying Index, the total Interest Payments made during the term of the Securities are as follows:

Principal Amount of Securities × 0.5925% per Interest Period × 60 Interest Periods

$$100 \times 0.5925\% \times 60 = 35.55$$

Therefore, the total amounts payable to the holder of a Security during the 60-month period from the Issue Date to the Maturity Date are:

(a) Redemption Amount: \$100.00

(b) Total Interest Payments made on Interest Payment Dates: \$35.55

(c) Total amount paid over the term of the Securities: \$135.55

The equivalent annually compounded rate of return in this example is 6.27%.
