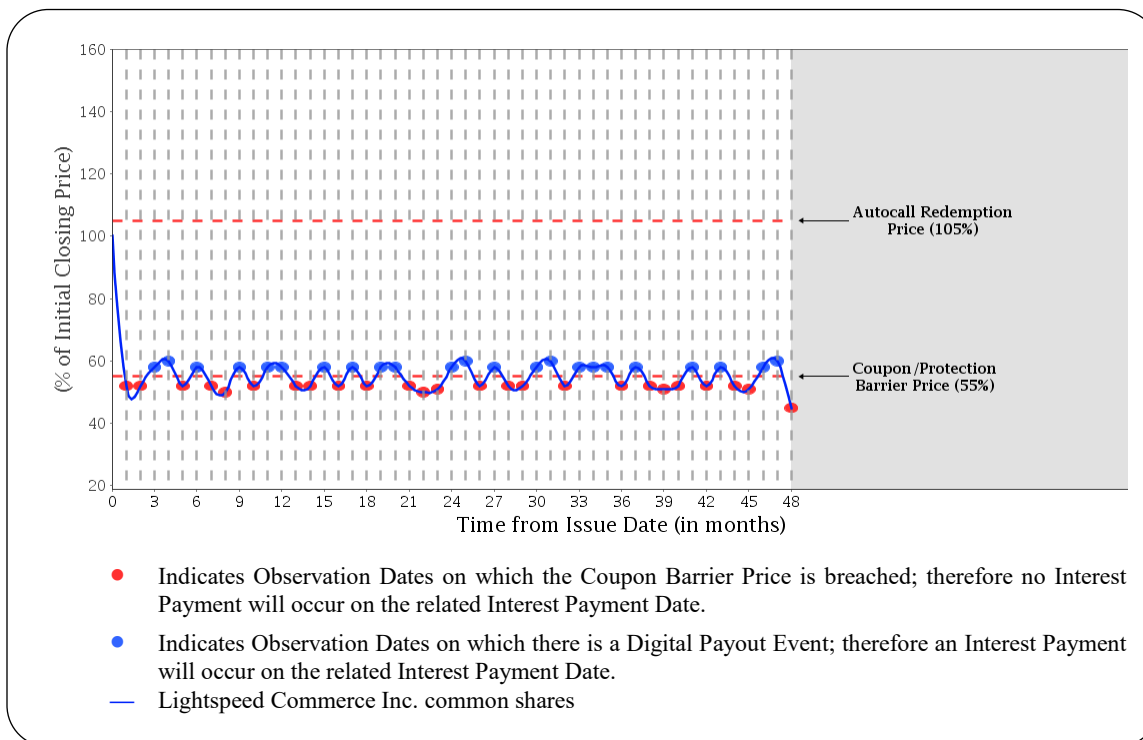

<b>Interest Payment Dates:</b>	The “ <b>Interest Payment Date</b> ” for an Interest Payment, if any, will occur monthly, on the third Business Day following the corresponding Observation Date for each such month, in each year that the Securities are outstanding and provided that the Securities are not redeemed by the Bank as described below. ## SAMPLE CALCULATIONS OF FINAL REDEMPTION AMOUNT OR AUTOCALL REDEMPTION AMOUNT AND INTEREST PAYMENTS

The examples set out below are included for illustration purposes only. The price performance of the Underlying Securities used to illustrate the calculation of the Final Redemption Amount or Autocall Redemption Amount and the Interest Payments over the term of the Securities is not an estimate or forecast of the price performance of the Underlying Securities or the Securities. All examples assume that a holder of the Securities has purchased Securities with an aggregate Principal Amount of US\$100 and that no Extraordinary Event has occurred. All examples assume a Coupon Barrier Price of 55.00% of the Initial Closing Price, a Protection Barrier Price of 55.00% of the Initial Closing Price and an Autocall Redemption Price of 105.00% of the Initial Closing Price. For convenience, each vertical line in the charts below represents both a hypothetical Observation Date and the next succeeding Interest Payment Date. Certain dollar amounts are rounded to the nearest whole cent.

### Example #1: Loss Scenario with Payment on the Maturity Date at Less Than the Principal Amount



In this scenario, there is no Autocall Observation Date on which the Closing Price is at or above the Autocall Redemption Price and, accordingly, the Securities would not be redeemed before the Maturity Date. On the Final Valuation Date, the Final Closing Price is below the Protection Barrier Price.

#### (i) Interest Payments

In this example, there is a Digital Payout Event on 23 of the 48 Observation Dates. On the other 25 Observation Dates, no Digital Payout Event would occur because the Closing Price is below the Coupon Barrier Price. Therefore, the Interest Payment of US\$1.625 per Interest Period would be payable for 23 Interest Periods on the applicable Interest Payment Date, for total Interest Payments of:

$$\begin{aligned} & \text{Principal Amount of Securities} \times 1.6250\% \text{ per Interest Period} \times 23 \text{ Interest Periods} \\ & \text{US\$100} \times 1.6250\% \times 23 = \text{US\$37.38} \end{aligned}$$

#### (ii) Final Redemption Amount

In this example, the Initial Closing Price ( $X_i$ ) is US\$20.07 and the Final Closing Price ( $X_f$ ) is US\$9.03. Therefore, the Final Redemption Amount is as follows:

$$\begin{aligned} & \text{US\$100} \times (X_f / X_i) \\ & \text{US\$100} \times (\text{US\$9.03} / \text{US\$20.07}) = \text{US\$44.99} \end{aligned}$$

Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

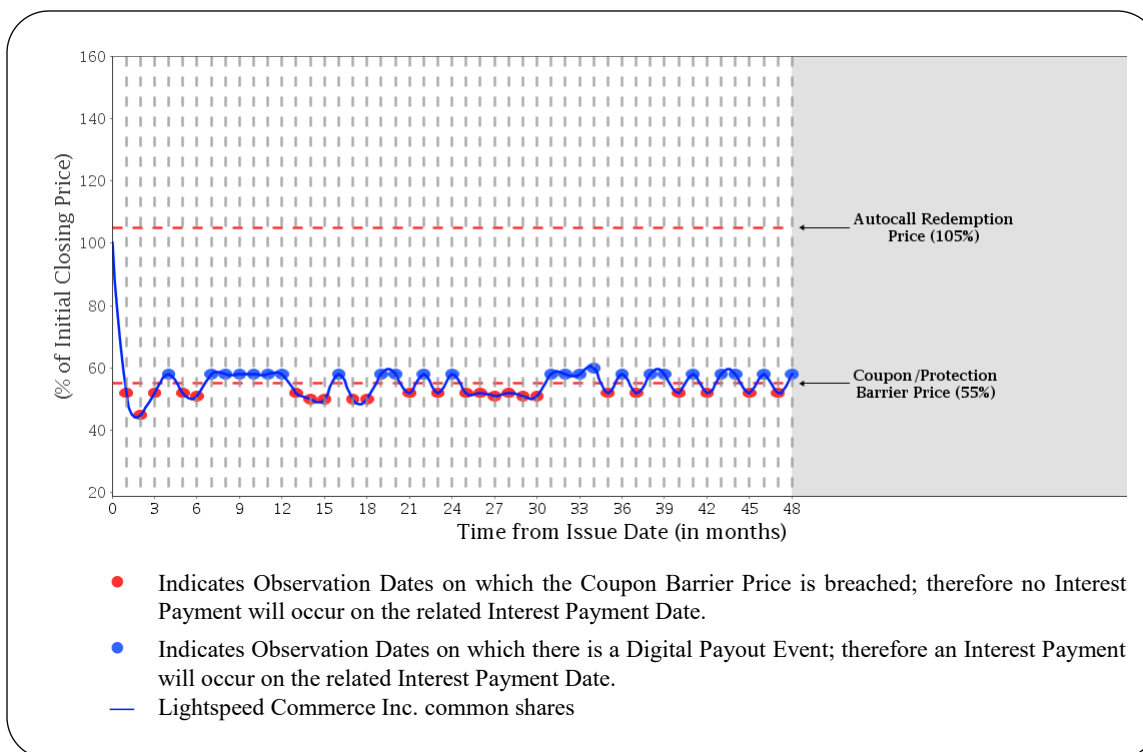
(a) Total Interest Payments: US\$37.38

(b) Final Redemption Amount: US\$44.99

(c) Total amount paid over the term of the Securities: US\$82.37

The equivalent annually compounded rate of return in this example is -4.73%.

## Example #2: Gain Scenario with Payment on the Maturity Date at the Principal Amount



In this scenario, there is no Autocall Observation Date on which the Closing Price is at or above the Autocall Redemption Price and, accordingly, the Securities would not be redeemed before the Maturity Date. On the Final Valuation Date, the Final Closing Price is at or above the Protection Barrier Price.

### (i) Interest Payments

In this example, there is a Digital Payout Event on 24 of the 48 Observation Dates. On the other 24 Observation Dates, no Digital Payout Event would occur because the Closing Price is below the Coupon Barrier Price. Therefore, the Interest Payment of US\$1.625 per Interest Period would be payable for 24 Interest Periods on the applicable Interest Payment Date for total Interest Payments of:

$$\begin{aligned} &\text{Principal Amount of Securities} \times 1.6250\% \text{ per Interest Period} \times 24 \text{ Interest Periods} \\ &\text{US\$100} \times 1.6250\% \times 24 = \text{US\$39.00} \end{aligned}$$

### (ii) Final Redemption Amount

In this example, since the Final Closing Price is US\$12.04, which is above its Protection Barrier Price of 55.00% of the Initial Closing Price of US\$20.07, the Final Redemption Amount per Security is equal to US\$100.00.

Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

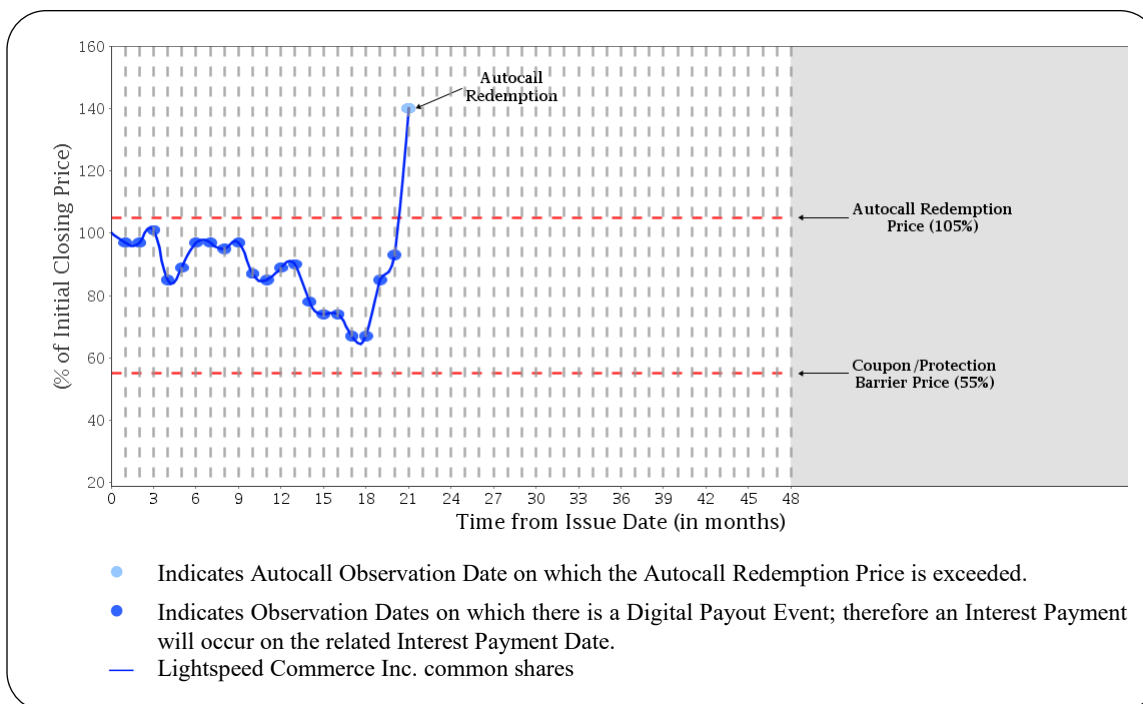
(a) Total Interest Payments: US\$39.00

(b) Final Redemption Amount: US\$100.00

(c) Total amount paid over the term of the Securities: US\$139.00

The equivalent annually compounded rate of return in this example is 8.58%.

### Example #3: Gain Scenario with Autocall Redemption Event



In this scenario, the Closing Price is at or above the Autocall Redemption Price on the Autocall Observation Date that falls 21 months into the term of the Securities. This would constitute an Autocall Redemption Event and, on the next succeeding Interest Payment Date, the Bank would redeem the Securities.

#### (i) Interest Payments

In this example, there is a Digital Payout Event on each of the 21 Observation Dates prior to the redemption of the Securities because the Closing Price is at or above the Coupon Barrier Price on each such date. Therefore, the Interest Payment of US\$1.625 per Interest Period would be payable for each Interest Period on the applicable Interest Payment Date (including on the Autocall Redemption Date), for total Interest Payments of:

$$\begin{aligned} & \text{Principal Amount of Securities} \times 1.6250\% \text{ per Interest Period} \times 21 \text{ Interest Periods} \\ & \text{US\$100} \times 1.6250\% \times 21 = \text{US\$34.13} \end{aligned}$$

#### (ii) Autocall Redemption Amount

The Autocall Redemption Amount per Security is equal to US\$100.00.

Therefore, the total amounts payable per Security from the Issue Date to the Autocall Redemption Date are:

(a) Total Interest Payments: US\$34.13

(b) Autocall Redemption Amount: US\$100.00

(c) Total amount paid over the term of the Securities: US\$134.13

The equivalent annually compounded rate of return in this example is 18.27%.
