The return on the Securities is linked to the adjusted returns of the Solactive Bank of Nova Scotia AR 4.12 Index (the "Underlying Index"). The Underlying Index is an adjusted return index that aims to track the gross total return performance of the BNS GTR Index (the "Target Index"), subject to a reduction of a synthetic dividend of 4.12 index points per annum calculated daily in arrears (the "Adjusted Return Factor"). The only constituent securities in the Target Index are the common shares of The Bank of Nova Scotia (the "Constituent Securities"). For the avoidance of doubt, the return on the Securities is linked to the Underlying Index and is not linked to the Target Index or the Constituent Securities. The Closing Level on January 26, 2024 was 62.88. The Adjusted Return Factor divided by the Closing Level was therefore equal to 6.5522% on January 26, 2024. If an Autocall Redemption Event does not occur, over the term of the Securities the sum of the Adjusted Return Factor will be approximately 28.84 index points, representing 45.8651% of the Closing Level on January 26, 2024. For the calculation of the level of the Target Index, any dividends or other distributions paid on the Constituent Securities are assumed to be reinvested across all of the Constituent Securities. As of January 26, 2024, the annual dividend yield on the Target Index was 6.7490%, representing an aggregate dividend yield of approximately 57.960% compounded annually over the term of the Securities, on the assumption that the dividend yield remains constant. Securities do not represent an interest in the Underlying Index, the Target Index or the Constituent Securities, and holders will have no right or entitlement to Constituent Securities including, without limitation, redemption rights (if any), voting rights or rights to receive dividends or other distributions paid on Constituent Securities.

Interest Payments:	Interest payments (the "Interest Payments" and each, an "Interest Payment"), if any, on the Securities will be payable on each Interest Payment Date, in arrears, at a fixed interest rate of 1.1700% monthly ending on an Interest Payment Date (an "Interest Period") for each Interest Period in which a Digital Payout Event occurs on the Observation Date occurring in the Interest Period. On the basis of the foregoing, the interest on each \$100 Principal Amount of Securities for an Interest Period in which a Digital Payout Event has occurred would equal \$100 × 1.1700%.

Autocall Redemption Date:

The "Autocall Redemption Date" for an Autocall Redemption Event, if applicable, will be the next succeeding Interest Payment Date, among those specified below, following the occurrence of such Autocall Redemption Event. For certainty, if the next succeeding Interest Payment Date is not a Business Day, such Interest Payment and the corresponding Autocall Redemption Date, if applicable, will be on the first following day that is a Business Day.

Payment at Maturity:

On the Maturity Date, if the Securities have not been previously redeemed, the amount payable (the "Final Redemption Amount") for each \$100 Principal Amount per Security will be equal to:

- (a) if the Final Index Level is greater than or equal to the Protection Barrier Level, \$100; or
- (b) if the Final Index Level is less than the Protection Barrier Level, an amount equal to the Index Return, but in any event not less than \$1.00.

In addition to the Final Redemption Amount, an Interest Payment will be paid on the Maturity Date if a Digital Payout Event occurs on the Final Valuation Date.

Index Return:

"Index Return" means $$100 \times (X_f/X_i)$,

- "Xf" means the Final Index Level, and
- "X_i" means the Initial Index Level.



Generally, to be effective on a Business Day, a redemption request will need to be initiated by 2:00 p.m. (Toronto time) on that Business Day (or such other time as may be established by Fundserv). Any request received after such time will be deemed to be a request sent and received on the next following Business Day.

Sample Calculations of Final Redemption Amount or Autocall Redemption Amount and Interest Payments: The examples set out below are included for illustration purposes only. The performance of the Underlying Index used to illustrate the calculation of the Final Redemption Amount or Autocall Redemption Amount and the Interest Payments over the term of the Securities is not an estimate or forecast of the performance of the Underlying Index or the Securities. All examples assume that a holder of the Securities has purchased Securities with an aggregate Principal Amount of \$100 and that no Extraordinary Event has occurred. All examples assume a Coupon Barrier Level of 75.00% of the Initial Index Level, a Protection Barrier Level of 75.00% of the Initial Index Level and an Autocall Redemption Level of 105.00% of the Initial Index Level. For convenience, each vertical line in the charts below represents both a hypothetical Observation Date and the next succeeding Interest Payment Date. Certain dollar amounts are rounded to the nearest whole cent.

Example #1: Loss Scenario with Payment on the Maturity Date at Less Than the Principal Amount



- Indicates Observation Dates on which the Coupon Barrier Level is breached;
 therefore no Interest Payment will occur on the related Interest Payment Date.
- Indicates Observation Dates on which there is a Digital Payout Event; therefore an Interest Payment will occur on the related Interest Payment Date.
- Solactive Bank of Nova Scotia AR 4.12 Index

In this scenario, there is no Autocall Observation Date on which the Closing Level is at or above the Autocall Redemption Level and, accordingly, the Securities would not be redeemed before the Maturity Date. On the Final Valuation Date, the Final Index Level is below the Protection Barrier Level.

(i) Interest Payments

In this example, there is a Digital Payout Event on 41 of the 84 Observation Dates. On the other 43 Observation Dates, no Digital Payout Event would occur because the Closing Level is below the Coupon Barrier Level. Therefore, the Interest Payment of \$1.17 per Interest Period would be payable for 41 Interest Periods on the applicable Interest Payment Date, for total Interest Payments of:

Principal Amount of Securities × 1.1700% per Interest Period × 41 Interest Periods

$$100 \times 1.1700\% \times 41 = 47.97$$

(ii) Final Redemption Amount

In this example, the Initial Index Level (X_i) is 62.88 and the Final Index Level (X_f) is 31.44. Therefore, the Final Redemption Amount is as follows:

$$$100 \times (X_f / X_i)$$

 $$100 \times (31.44 / 62.88) = 50.00


Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

- (a) Total Interest Payments: \$47.97
- (b) Final Redemption Amount: \$50.00
- (c) Total amount paid over the term of the Securities: \$97.97

The equivalent annually compounded rate of return in this example is -0.29%.

Sample Calculations: (continued)

Example #2: Gain Scenario with Payment on the Maturity Date at the Principal Amount



- Indicates Observation Dates on which the Coupon Barrier Level is breached; therefore no Interest Payment will occur on the related Interest Payment Date.
- Indicates Observation Dates on which there is a Digital Payout Event; therefore an Interest Payment will occur on the related Interest Payment Date.
- Solactive Bank of Nova Scotia AR 4.12 Index

In this scenario, there is no Autocall Observation Date on which the Closing Level is at or above the Autocall Redemption Level and, accordingly, the Securities would not be redeemed before the Maturity Date. On the Final Valuation Date, the Final Index Level is at or above the Protection Barrier Level.

(i) Interest Payments

In this example, there is a Digital Payout Event on 42 of the 84 Observation Dates. On the other 42 Observation Dates, no Digital Payout Event would occur because the Closing Level is below the Coupon Barrier Level. Therefore, the Interest Payment of \$1.17 per Interest Period would be payable for 42 Interest Periods on the applicable Interest Payment Date for total Interest Payments of:

Principal Amount of Securities × 1.1700% per Interest Period × 42 Interest Periods

$$100 \times 1.1700\% \times 42 = 49.14$$

(ii) Final Redemption Amount

In this example, since the Final Index Level is 48.42, which is above the Protection Barrier Level of 75.00% of the Initial Index Level of 62.88, being 47.16, the Final Redemption Amount per Security is equal to \$100.00.


Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

- (a) Total Interest Payments: \$49.14
- (b) Final Redemption Amount: \$100.00
- (c) Total amount paid over the term of the Securities: \$149.14

The equivalent annually compounded rate of return in this example is 5.88%.

Sample Calculations: (continued)

Example #3: Gain Scenario with Autocall Redemption Event



- Indicates Autocall Observation Date on which the Autocall Redemption Level is exceeded.
- Indicates Observation Dates on which there is a Digital Payout Event; therefore an Interest Payment will occur on the related Interest Payment Date.
- Solactive Bank of Nova Scotia AR 4.12 Index

In this scenario, the Closing Level is at or above the Autocall Redemption Level on the Autocall Observation Date that falls 33 months into the term of the Securities. This would constitute an Autocall Redemption Event and, on the next succeeding Interest Payment Date, the Bank would redeem the Securities.

(i) Interest Payments

In this example, there is a Digital Payout Event on each of the 33 Observation Dates prior to the redemption of the Securities because the Closing Level is at or above the Coupon Barrier Level on each such date. Therefore, the Interest Payment of \$1.17 per Interest Period would be payable for each Interest Period on the applicable Interest Payment Date (including on the Autocall Redemption Date), for total Interest Payments of:

Principal Amount of Securities × 1.1700% per Interest Period × 33 Interest Periods

$$100 \times 1.1700\% \times 33 = 38.61$$

(ii) Autocall Redemption Amount

The Autocall Redemption Amount per Security is equal to \$100.00.

Therefore, the total amounts payable per Security from the Issue Date to the Autocall Redemption Date are:

- (a) Total Interest Payments: \$38.61
- (b) Autocall Redemption Amount: \$100.00
- (c) Total amount paid over the term of the Securities: \$138.61

The equivalent annually compounded rate of return in this example is 12.61%.
