The Underlying Index is an adjusted return index that aims to track the gross total return performance of the Solactive Canada Blue Chip GTR Index (the " Target Index "), subject to a reduction of a synthetic dividend of 75 index points per annum, calculated daily in arrears (the " Adjusted Return Factor "). For the avoidance of doubt, the return on the Securities is linked to the Underlying Index and is not linked to the Target Index. The Closing Level on July 11, 2024 was 1,243.50. The Adjusted Return Factor divided by the Closing Level was therefore equal to 6.0314% on July 11, 2024. If an Autocall Redemption Event does not occur, over the term of the Securities the sum of the Adjusted Return Factor will be approximately 525 index points, representing 42.2195% of the Closing Level on July 11, 2024. For the calculation of the level of the Target Index, any dividends or other distributions paid on the constituent securities of the Target Index are assumed to be reinvested across all of the constituent securities of the Target Index. As of July 11, 2024, the annual dividend yield on the Target Index was 6.2249%, representing an aggregate dividend yield of approximately 52.6105 % compounded annually over the term of the Securities, on the assumption that the dividend yield remains constant.



Sample Calculations of Final Redemption Amount or Autocall Redemption Amount and Interest Payment: The following examples show how the return on the Securities would be calculated under different scenarios. These examples are included for illustration purposes only. The performance of the Underlying Index used in the examples is not an estimate or forecast of the performance of the Underlying Index or the Securities. The actual performance of the Underlying Index and the Securities will be different from these examples and the differences may be material. All examples assume that a holder of the Securities has purchased Securities with an aggregate Principal Amount of \$100 and that no Extraordinary Event has occurred. For convenience, each vertical line in the charts below represents both a hypothetical Observation Date and the next succeeding Interest Payment Date. Where applicable, dollar amounts are rounded to the nearest whole cent.



Example #1: Loss Scenario with Payment on the Maturity Date at Less Than the Principal Amount

• Autocall Redemption Level: (i) 95.00% of the Initial Index Level with respect to the first and second Observation Dates, and (ii) 100.00% of the Initial Index Level with respect to the third to seventh Observation Dates.

In this scenario, the Closing Level is below the Autocall Redemption Level on all Observation Dates so the Securities would not be redeemed before the Maturity Date. On the Final Valuation Date, the Final Index Level is below the Protection Barrier Level.

(i) Interest Payment

No Autocall Redemption Event occurs because the Closing Level at each Observation Date is below the Autocall Redemption Level. Therefore, an Interest Payment would not be payable on any Interest Payment Date.

(ii) Final Redemption Amount

In this example, the Initial Index Level (X_i) is 1,243.50 and the Final Index Level (X_f) is 833.14. Therefore, the Final Redemption Amount is as follows:

$$100.00 \times (X_f / X_i)$$

100.00 × (833.14 / 1,243.50) = \$67.00

Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

(a) Interest Payment: \$0.00

(b) Final Redemption Amount: \$67.00

(c) Total amount paid over the term of the Securities: \$67.00

The equivalent annually compounded rate of return in this example is -5.56%.

Example #2: Scenario with Payment on the Maturity Date at the Principal Amount

• Autocall Redemption Level: (i) 95.00% of the Initial Index Level with respect to the first and second Observation Dates, and (ii) 100.00% of the Initial Index Level with respect to the third to seventh Observation Dates.

In this scenario, the Closing Level is below the Autocall Redemption Level on all Observation Dates, so the Securities would not be redeemed before the Maturity Date. On the Final Valuation Date, the Final Index Level is at or above the Protection Barrier Level but is below the Autocall Redemption Level.

(i) Interest Payment

No Autocall Redemption Event occurs because the Closing Level at each Observation Date is below the Autocall Redemption Level. Therefore, an Interest Payment would not be payable on any Interest Payment Date.

(ii) Final Redemption Amount

In this example, the Final Index Level is greater than or equal to the Protection Barrier Level. Therefore, the Final Redemption Amount is \$100.00.

Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

(a) Interest Payment: \$0.00


(b) Final Redemption Amount: \$100.00

(c) Total amount paid over the term of the Securities: \$100.00

The equivalent annually compounded rate of return in this example is 0.00%.

Example #3: Gain Scenario with Autocall Redemption Event



• Autocall Redemption Level: (i) 95.00% of the Initial Index Level with respect to the first and second Observation Dates, and (ii) 100.00% of the Initial Index Level with respect to the third to seventh Observation Dates.

In this scenario, the Closing Level is at or above the Autocall Redemption Level on the Observation Date that falls 36 months into the term of the Securities. This would constitute an Autocall Redemption Event and the Bank would redeem the Securities on the next succeeding Autocall Redemption Date. An Interest Payment would be payable on the third Interest Payment Date.

(i) Interest Payment

The Initial Index Level (X_i) is 1,243.50 and the Closing Level on the third Observation Date (X_f) is 1,740.90; therefore, there is an Autocall Redemption Event on the third Observation Date. On the first and second Observation Dates, no Autocall Redemption Event would occur because the Closing Level at each such Observation Date is below the Autocall Redemption Level. Therefore, the Interest Payment payable on the Autocall Redemption Date would be calculated as follows:





The equivalent annually compounded rate of return in this example is 8.36%.

• Autocall Redemption Level: (i) 95.00% of the Initial Index Level with respect to the first and second Observation Dates, and (ii) 100.00% of the Initial Index Level with respect to the third to seventh Observation Dates.

In this scenario, the Closing Level is at or above the Autocall Redemption Level on the final Observation Date. This would constitute an Autocall Redemption Event and an Interest Payment would be payable on the Maturity Date (being the final Interest Payment Date).

(i) Interest Payment

The Initial Index Level (X_i) is 1,243.50 and the Final Index Level (X_f) is 1,367.85; therefore, there is an Autocall Redemption Event on the Final Valuation Date (being the final Observation Date). On the first through sixth Observation Dates, no Autocall Redemption Event would occur because the Closing Level at each such Observation Date is below the Autocall Redemption Level. Therefore, the Interest Payment payable on the Maturity Date (being the final Interest Payment Date) would be calculated as follows:

The Index Return is calculated as follows:

$((X_f / X_i) - 1) \times 100.00

$$((1,367.85 / 1,243.50) - 1) \times $100.00 = $10.00$$

Since the Index Return is less than \$44.05, the Interest Payment is \$44.05.

(ii) Final Redemption Amount

The Final Redemption Amount per Security is equal to \$100.00.

Therefore, the total amounts payable per Security from the Issue Date to the Maturity Date are:

(a) Interest Payment: \$44.05

(b) Final Redemption Amount: \$100.00

(c) Total amount paid over the term of the Securities: \$144.05

The equivalent annually compounded rate of return in this example is 5.35%.

Initial Estimated Value:

The initial estimated value of the Securities on or about the date of the Pricing Supplement was \$95.85 per Security, which is less than the price to the public and is not an indication of the actual profit to the Bank or its affiliates.
