Underlying Index:	The return on the Securities is linked to the performance of the Solactive Canada Blue Chip III AR Index (the "Underlying Index"). The Underlying Index is an adjusted return index that aims to track the gross total return performance of the Solactive Canada Blue Chip III GTR Index (the "Target Index"), subject to a reduction of a synthetic dividend of 180 index points per annum (the "Adjusted Return Factor"). For the avoidance of doubt, the return on the Securities is linked to the Underlying Index and is not linked to the Target Index. The Closing Level on July 4, 2025 was 3,300.16. The Adjusted Return Factor divided by the Closing Level was therefore equal to 5.4543% on July 4, 2025. Over the term of the Securities the sum of the Adjusted Return Factor will be approximately 1,260 index points, representing 38.1800% of the Closing Level on July 4, 2025. For the calculation of the level of the Target Index, any dividends or other distributions paid on the constituent securities of the Target Index are assumed to be reinvested across all of the constituent securities of the Target Index. As of July 4, 2025, the annual dividend yield on the Target Index was 4.363%, representing an aggregate dividend yield of approximately 34.842% compounded annually over the term of the Securities, on the assumption that the dividend yield remains constant.

Final Index Level: The Closing Level as published by the Index Sponsor on the Final Valuation Date.

Final Valuation Date: July 30, 2032.

Closing Level: The official closing level of the Underlying Index as announced by the Index Sponsor for the relevant date, as determined by the Calculation Agent.

Maturity Date: August 5, 2032.

Payment at Maturity: Payment at maturity will be based on the performance (or “**Percentage Change**”) of the Underlying Index measured from the Initial Index Level to the Final Index Level. The amount payable (the “**Redemption Amount**”) on each Security at maturity will be determined as follows:

If the Percentage Change in the Underlying Index is **greater than or equal to 106.00%**, then the Redemption Amount will be:

- $\$100.00 + (\$100.00 \times \text{Percentage Change})$

If the Percentage Change in the Underlying Index is **greater than or equal to 0.00%, but less than 106.00%**, then the Redemption Amount will be:

- $\$100.00 + (\$100.00 \times \text{Booster Amount})$

If the Percentage Change in the Underlying Index is **less than 0.00% and greater than or equal to -20.00%**, then the Redemption Amount will be \$100.00.

If the Percentage Change in the Underlying Index is **less than -20.00%**, then the Redemption Amount will be:

- $\$100.00 + (\$100.00 \times \text{Percentage Change})$

All dollar amounts will be rounded to the nearest whole cent. The minimum payment at maturity is \$1.00.

Percentage Change: The amount, expressed as a percentage rounded to three decimal places, equal to:

$$\frac{(\text{Final Index Level} - \text{Initial Index Level})}{\text{Initial Index Level}}$$

Initial Index Level

Booster Amount: 106.00%.

The Booster Amount will only affect the Redemption Amount if the Percentage Change is greater than or equal to 0.00% and less than 106.00%.

Barrier Level: 80.00% of the Initial Index Level.

Secondary Market: Fundserv, RBC13226

Generally, to be effective on a Business Day, a redemption request will need to be initiated by 2:00 p.m. (Toronto time) on that Business Day (or such other time as may be established by Fundserv). Any request received after such time will be deemed to be a request sent and received on the next following Business Day.

SAMPLE CALCULATIONS

The following examples show how the return on the Securities would be calculated under different scenarios. These examples are included for illustration purposes only. The performance of the Underlying Index used in the examples to illustrate the calculation of the Redemption Amount is not an estimate or forecast of the performance of the Underlying Index or the Securities. The actual performance of the Underlying Index and the Securities will be different from these examples and the differences may be material. All examples assume that a holder of the Securities has purchased Securities with an aggregate Principal Amount of \$100.00 and that no Extraordinary Event has occurred. Where applicable, dollar amounts shown below are rounded to the nearest whole cent for ease of reading, but the amount(s) payable to an investor per Security may reflect more decimal places.

Example #1 — Calculation of the Redemption Amount where the Percentage Change is negative, declining by more than 20.00% (i.e., the Final Index Level is below the Barrier Level)

Assuming that the Initial Index Level is 3,300.16 and the Final Index Level is 1,650.08, the Percentage Change would be calculated as follows:

$$\text{Percentage Change} = (1,650.08 - 3,300.16) / 3,300.16 = -0.50000 \text{ or } -50.000\%$$

Since the Percentage Change is negative, declining by more than 20.00% (i.e., the Final Index Level is below the Barrier Level), the Redemption Amount is calculated as follows:

$$\text{Redemption Amount} = \$100.00 + (\$100.00 \times -50.000\%) = \$50.00$$

In this example, the Redemption Amount results in a loss on the Principal Amount equivalent to an annually compounded rate of return of -9.43%.

Example #2 — Calculation of the Redemption Amount where the Percentage Change is negative, declining by 20.00% or less (i.e., the Final Index Level is equal to or above the Barrier Level, but the Percentage Change is less than 0.00%)

Assuming that the Initial Index Level is 3,300.16 and the Final Index Level is 2,970.14, the Percentage Change would be calculated as follows:

$$\text{Percentage Change} = (2,970.14 - 3,300.16) / 3,300.16 = -0.10000 \text{ or } -10.000\%$$

Since the Percentage Change is negative, declining by 20.00% or less (i.e., the Final Index Level is equal to or above the Barrier Level), the Redemption Amount is \$100.00.

In this example, the Redemption Amount provides a return on the Principal Amount equivalent to an annually compounded rate of return of 0.00%.

Example #3 — Calculation of the Redemption Amount where the Percentage Change is greater than or equal to 0.00% but less than 106.00%

Assuming that the Initial Index Level is 3,300.16 and the Final Index Level is 4,950.24, the Percentage Change would be calculated as follows:

$$\text{Percentage Change} = (4,950.24 - 3,300.16) / 3,300.16 = 0.50000 \text{ or } 50.000\%$$

Since the Percentage Change is greater than or equal to 0.00% but less than 106.00%, the Redemption Amount is calculated as follows:

$$\text{Redemption Amount} = \$100.00 + (\$100.00 \times 106.000\%) = \$206.00$$

In this example, the Redemption Amount provides a return on the Principal Amount equivalent to an annually compounded rate of return of 10.88%.

Example #4 — Calculation of the Redemption Amount where the Percentage Change is greater than or equal to 106.00%

Assuming that the Initial Index Level is 3,300.16 and the Final Index Level is 7,425.36, the Percentage Change would be calculated as follows:

$$\text{Percentage Change} = (7,425.36 - 3,300.16) / 3,300.16 = 1.25000 \text{ or } 125.000\%$$

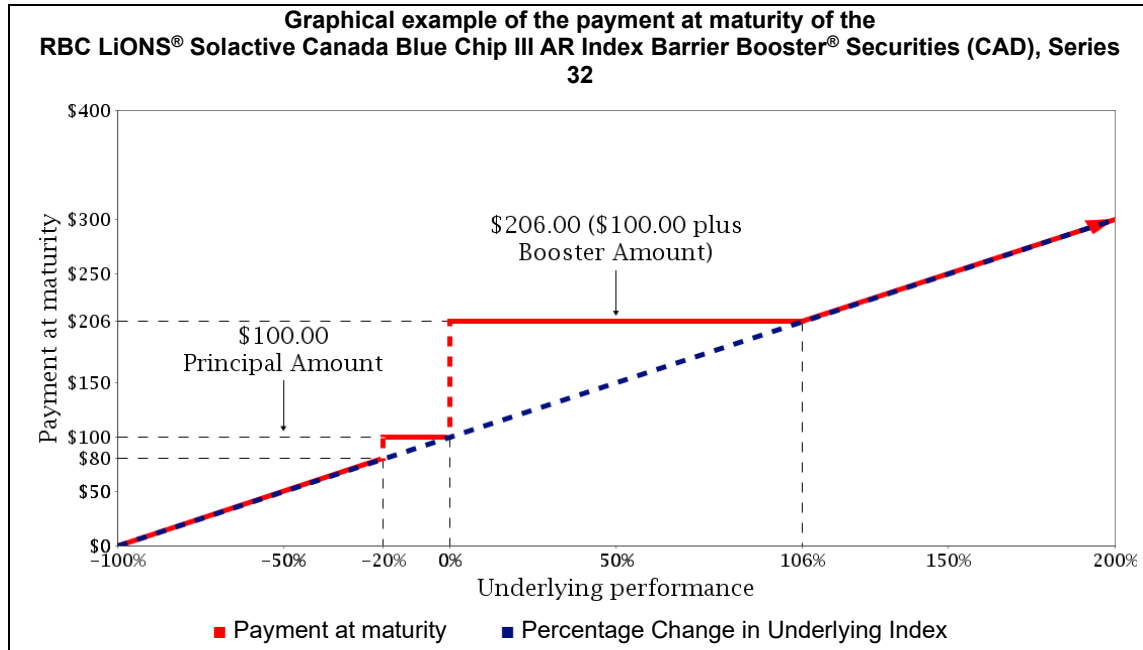
Since the Percentage Change is greater than or equal to 106.00%, the Redemption Amount is calculated as follows:

$$\text{Redemption Amount} = \$100.00 + (\$100.00 \times 125.000\%) = \$225.00$$

In this example, the Redemption Amount provides a return on the Principal Amount equivalent to an annually compounded rate of return of 12.28%.

GRAPHICAL DESCRIPTION OF THE PAYMENT AT MATURITY:

The graph set out below illustrates the payment at maturity on the Securities in a range of scenarios depending on the performance of the Underlying Index during the term of the Securities. The performance of the Underlying Index used in the graph is not an estimate or forecast of the performance of the Underlying Index or the Securities. This graph shows a limited range of hypothetical returns on the Underlying Index and is intended to be representative of that range only. Returns on the Underlying Index not shown on the graph are possible. The graph is included for illustration purposes only, and in all cases, the return on the Securities will be calculated using the formulas set out in this pricing supplement. There can be no assurance that any specific return on the Securities will be achieved. The graph assumes that a holder of the Securities has purchased Securities with an aggregate Principal Amount of \$100.00 and that no Extraordinary Event has occurred. The minimum payment at maturity is \$1.00.
